Method of Production

Distilled gin is produced by redistilling ethyl alcohol of agricultural origin with an initial strength of 96% ABV (in stills traditionally used for gin), in the presence of juniper berries and of other natural botanicals, to give a predominant juniper taste. The product is a Distilled Gin complying with the EU Spirit Drinks Regulation definitions and the standards required for Distilled Gins.

Packaging

The packaging used meets relevant requirements under EU or marketplace laws. The product is packaged using tamperproof seals/closures so that the safety of the product can be assured. All materials used in contact with the product comply with the relevant EU or market regulations and migration levels are within acceptable limits as laid down in the relevant laws.

Labelling

Product is labelled according to EC or market rules on labelling of alcoholic beverages.

Storage and Transport Conditions
